- . The General Conditions of Contract will form part of all bid documents and may not be amended.
- . Special Conditions of Contract (SCC) relevant to a specific Bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

The following terms shall be interpreted as indicated:

- 1.1 **“Closing time”** means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 **“Contract”** means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 **“Contract price”** means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 **“Corrupt practice”** means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 **“Countervailing duties”** are imposed in cases where an enterprise abroad is subsidised by its government and encouraged to market its products internationally.
- 1.6 **“Country of origin”** means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognised new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 **“Day”** means calendar day.
- 1.8 **“Delivery”** means delivery in compliance of the conditions of the contract or order.
- 1.9 **“Delivery ex stock”** means immediate delivery directly from stock actually on hand.
- 1.10 **“Delivery into consignees store or to his site”** means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 **“Dumping”** occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 **“Force majeure”** means an event beyond the control of the supplier and not involving the supplier’s fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 **“Fraudulent practice”** means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 **“GCC”** means the General Conditions of Contract.
- 1.15 **“Goods”** means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 **“Imported content”** means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 **“Local content”** means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 **“Manufacture”** means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 **“Order”** means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 **“Project site,”** where applicable, means the place indicated in bidding documents.
- 1.21 **“Purchaser”** means the organization purchasing the goods.

14.Spare parts	14.1 As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier: (a) such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and (b) in the event of termination of production of the spare parts: (i) Advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and (ii) Following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.
15.Warranty	15.1 The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models and that, they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination. 15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC. 15.3 The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty. 15.4 Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser. 15.5 If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.
16.Payment	16.1 The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC. 16.2 The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract. 16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier. 16.4 Payment will be made in Rand unless otherwise stipulated in SCC.

1. INTRODUCTION

The Limpopo Department of Health (LDoH) - Health Care Facilities that admit/ treat patients, some of whom, depending on their medical conditions, are transferred to other referral Health Care Facilities within the Limpopo Province and other Provinces of South Africa, when need arises. Some of these referred patients demise at those referral Health Care Facilities and their human remains need to be transported back to their original Health Care Facilities of admittance. In most times Health Care Facilities are full of corpses resulting in a shortage of storage/ failure to accommodate more corpses. There are times that, the mortuaries store unidentified and/or unclaimed corpses of persons who died within the LDoH Health Care Facilities, who subsequently need to be accorded paupers' burials.

2. BACKGROUND

For the transportation and storage of corpses including paupers' burials to be effectively performed, there is a need to acquire the services of a competent service provider(s) who will enter into contract with the Limpopo Province Department of Health for the transportation and storage of corpses (in their premises) including rendering of paupers' burials.

3. OBJECTIVES

Qualifying bidders are invited to submit bids for the transportation and storage of corpses including rendering of paupers' burials for a period of 36 months, as and when a need arises.

4. SCOPE OF WORK

4.1. The appointed service provider(s) is/are expected to transport corpses from the Health Care Facilities where the death occurred to the Health Care Facilities where the patients were originally admitted, and/or store corpses at the service provider's mortuary, including rendering paupers' burial (When applicable) at the request of the LDoH.

4.2. The bidders are required to specify their tariffs per kilometre in respect of the shortest route surface and provide proof of toll fees payment

4.3. **Distances from *the service provider's business premises***

4.3.1 Transportation of corpses

4.3.1.1 The service provider'(s) will be expected to collect next of kin from the original Health Care Facilities of admission to Health Care Facilities where death occurred and back to the

admitting Health Care Facilities, the service provider will be paid for the kilometres travelled)

- 4.3.1.2 The Department will only be responsible for payment of the appointed service provider within the district where business is located and the admitting Health Care Facility and again up from the admitting Health Care Facility back to the service provider's business premises.
- 4.3.1.3 The department will pay for the kilometres through the shortest route surface from the admitting Health Care Facility to where death occurred (the Health Care Facility where the patient was transferred to) and back to the admitting Health Care Facility , unless there is road closure or detours.
- 4.3.1.4 The bidders should have a valid certificate of competence as per regulations 363 of 2013 issued by government gazette 36473 of 22 May 2013 on Regulations relating to Management of Human Remains.

4.3.2 The Rendering of Paupers' Burials

- 4.3.2.1 Arrangements for the paupers' burials will be the responsibility of the service provider(s).
- 4.3.2.2 The Department will pay for tariffs from the service provider's premises to the Health Care Facility, and from the Health Care Facility to the service provider's premises to prepare the corpse for burial.
- 4.3.2.3 The Department will be responsible for the round trip (kilometres) between the service provider's premises to where the corpse(s) is/are stored and to the graveyard where the burial must take place. The graveyard to be used must be within the district municipality where the Health Care Facilities are situated, considering the shortest route surface.
- 4.3.2.4 The service provider(s) is/are expected to conduct pauper's burial within 14 days upon request by the LDoH.
- 4.4. Service provider premises refer to the business operation where the Department will conduct inspection prior to the award of the bid.
- 4.5. In case where the service provider collects more than one corpse in one vehicle, the Department will only pay for one trip while for storage of corpses, the department will pay per corpse.
- 4.6. Bidders are encouraged to bid for Health Care Facilities that are closest to their business operations.
- 4.7. The corpse must be conveyed in a closed roadworthy vehicle suitable for such service/transportation.

- 4.8. Successful bidder(s) must arrange for issue of removal order / permit by the responsible authority at the place of death.
- 4.9. The bidder shall be considered for only in the district of their footprint. In circumstances where a bidder has footprint in various districts, a letter indicating business addresses to be considered must accompany the bid. (The department shall conduct site inspection per site)
