## THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME

### INTRODUCTION

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

### 1. PILLARS OF THE PROGRAMME

- 1.1 The NIP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US\$ 10 million or other currency equivalent to US\$ 10 million will have an NIP obligation. This threshold of US\$ 10 million can be reached as follows:
  - (a) Any single contract with imported content exceeding US \$10 million; or
  - (b) Multiple contracts for the same goods, works or services each with imported content exceeding US \$3 million awarded to one seller over a 2 year period which in total exceeds US \$10 million; or
  - (c) A contract with a renewable option clause, where should the option be exercised the total value of the imported content will exceed US \$10 million.
  - (d) Multiple suppliers of the same goods, works or services under the same contract, where the value of the imported content of each allocation is equal to or exceeds US\$ 3 million worth of goods, works or services to the same government institution, which in total over a two (2) year period exceeds US\$10 million.
- 1.2 The NIP obligation applicable to suppliers in respect of sub-paragraphs 1.1 (a) to 1.1 (c) above will amount to 30 % of the imported content whilst suppliers in respect of paragraph 1.1 (d) shall incur 30% of the total NIP obligation on a *pro-rata* basis.
- 1.3 To satisfy the NIP obligation, the DTI would negotiate and conclude agreements such as investments, joint ventures, sub-contracting, licensee production, export promotion, sourcing arrangements and research and development (R&D) with partners or suppliers.
- 1.4 A period of seven years has been identified as the time frame within which to discharge the obligation.

## **2 REQUIREMENTS OF THE DEPARTMENT OF TRADE AND INDUSTRY**

- 2.1 In order to ensure effective implementation of the programme, successful bidders (contractors) are required to, immediately after the award of a contract that is in excess of **R10 million** (ten million Rands), submit details of such a contract to the DTI for reporting purposes.
- 2.2 The purpose for reporting details of contracts in excess of the amount of R10 million (ten million Rands) is to cater for multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as provided for in paragraphs 1.1.(b) to 1.1. (d) above.

## **3 BID SUBMISSION AND CONTRACT REPORTING REQUIREMENTS OF BIDDERS AND SUCCESSFUL BIDDERS (CONTRACTORS)**

- 3.1 Bidders are required to sign and submit this Standard Bidding Document (SBD 5) together with the bid on the closing date and time.
- 3.2 In order to accommodate multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as indicated in sub-paragraphs 1.1 (b) to 1.1 (d) above and to enable the DTI in determining the NIP obligation, successful bidders (contractors) are required, immediately after being officially notified about any successful bid with a value in excess of R10 million (ten million Rands), to contact and furnish the DTI with the following information:
- Bid / contract number.
  - Description of the goods, works or services.
  - Date on which the contract was accepted.
  - Name, address and contact details of the government institution.
  - Value of the contract.
  - Imported content of the contract, if possible.

## **4. PROCESS TO SATISFY THE NIP OBLIGATION**

- 4.1 Once the successful bidder (contractor) has made contact with and furnished the DTI with the information required, the following steps will be followed:
- a. the contractor and the DTI will determine the NIP obligation;
  - b. the contractor and the DTI will sign the NIP obligation agreement;
  - c. the contractor will submit a performance guarantee to the DTI;
  - d. the contractor will submit a business concept for consideration and approval by the DTI;
  - e. upon approval of the business concept by the DTI, the contractor will submit detailed business plans outlining the business concepts;
  - f. the contractor will implement the business plans; and
  - g. the contractor will submit bi-annual progress reports on approved plans to the DTI.

- 4.2 The NIP obligation agreement is between the DTI and the successful bidder (contractor) and, therefore, does not involve the purchasing institution.

## 2 DEFINITIONS

- (a) **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) **“B-BBEE status level of contributor”** means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) **“EME”** means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) **“functionality”** means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) **“prices”** includes all applicable taxes less all unconditional discounts;
- (h) **“proof of B-BBEE status level of contributor”** means:
  - 1) B-BBEE Status level certificate issued by an authorized body or person;
  - 2) A sworn affidavit as prescribed by the B-BBEE Codes of Good Practice;
  - 3) Any other requirement prescribed in terms of the B-BBEE Act;

<b>Administrative Requirements</b>	This are inherent requirements of the bid, therefore failure to comply or satisfy any of the requirements shall result in the invalidation of the Bid during administrative compliance stage.
<b>Bid</b>	A written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services or goods.
<b>Bidder Agent</b>	Any person mandated by a prime Bidder or consortium/joint venture to do business for and on behalf of, or to represent in a business transaction, the prime Bidder and thereby acquire rights for the prime Bidder or consortium/joint venture against Department of Health or an organ of state and incur obligations binding the prime Bidder or consortium/joint venture in favour of the Department.
<b>Bidders</b>	Any enterprise, consortium or person, partnership, company, close corporation, firm or any other form of enterprise or person, legal or natural, which has been invited by the Department of Health to submit a bid in response to this bid invitation.
<b>Client</b>	Government departments, provincial and local administrations that participate in Department of Health procurement processes.
<b>Comparative Price</b>	The price after deduction or addition of non-firm price factors, unconditional discounts, etc.
<b>Consortium</b>	Several entities joining forces as an umbrella entity to gain a strategic collaborative advantage by combining their expertise, capital, efforts, skills and knowledge for the purpose of executing this bid.
<b>Department</b>	The Limpopo Department of Health (LDoH)
<b>Disability</b>	In respect of a person, a permanent impairment of a physical, intellectual, or sensory function, which results in restricted, or lack of, ability to perform an activity in the manner, or within the range, considered normal for a human being.
<b>Firm Price</b>	The price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition or abolition of customs or excise duty and any other duty, levy or tax

## **2. OBJECTIVE**

- 2.1. Qualifying bidders are hereby invited to submit bids for the supply and delivery of pharmaceutical diagnostic sets and disposable test strips in the Limpopo Department of Health, as and when the need arises, for a period of thirty-six (36) months.
- 2.2. This document serves to set out the terms of reference for the services and supplies required under this bid.

## **3. INTRODUCTION**

- 3.1. The Limpopo Department of Health, through the Pharmaceutical Depot, procures, stores and distributes pharmaceutical diagnostic sets and disposable test strips to healthcare facilities which use these products on daily basis.

## **4. BACKGROUND**

- 4.1. In order to meet the demands of the healthcare facilities, in terms of sourcing the pharmaceutical diagnostic sets and disposable test strips for efficient and effective service delivery, the Department has decided to appoint a competent service provider through competitive bidding for the supply and delivery of pharmaceutical diagnostic sets and disposable test strips, as and when the need arises.

## **5. SCOPE OF WORK**

- 5.1. The supplier will be provisioning the pharmaceutical depot in the Limpopo Department of Health, as and when the need arises, for a period of thirty-six (36) months.
- 5.2. The supplies must be delivered to healthcare facilities where the official purchase order was issued or as per the delivery address.
- 5.3. The successful bidder is expected to supply and deliver the following pharmaceutical diagnostic sets and disposable test strips as indicated below.

- 5.4. **Delivery period:** Initial first order delivery period within 21 days of receipt of the official purchased order, thereafter expected delivery lead time must not exceed 14 working days, subsequent orders. The supplier shall ensure the integrity of the goods while in transit.
- 5.5. **Ordering Restrictions:** The purchase order quantities shall not be restricted to minimum quantities.
- 5.6. Delivery of products must be made in accordance with the instructions appearing on the official purchase order.
- 5.7. All deliveries or dispatches must be accompanied by a delivery note and an invoice stating the official order number against which the delivery has been effected.
- 5.8. The instructions appearing on the official order regarding the supply, dispatch and submission of invoices must be strictly adhered to.
- 5.9. Deliveries not complying with the bid specifications shall be returned to the contractor at the contractor's expense.
- 5.10. The contractor is responsible for the delivery and cost of delivery of items awarded to them, as and when ordered, as per delivery address.
- 5.11. Prospective bidders will be invited to sample evaluation to demonstrate their products.
- 5.12. Successful bidders will be expected to train end-users on the products at their own expenses within sixty (60) days upon acceptance of the award and continuously (ongoing training) upon request.

## **6. CONTAINERS**

- 6.1. The function of a container for the products is to maintain the quality, safety and stability of its contents.
- 6.2. Containers shall withstand the mechanical hazards of handling and transport, prevent leakage, and provide an appropriate level of protection from environmental conditions. Damaged containers shall not be received.
- 6.3. The materials for the construction of containers shall have no chemical or physical effect on the device.
- 6.4. Products are to be packed in suitable containers that ensure adequate protection of goods against deterioration in storage due to exposure to light and / or moisture. All products must be packed in containers that are specifically developed for the product.
- 6.5. The batch number and expiry date shall be clearly displayed on the containers

## **7. PACKAGING**

- 7.1. All deliveries made against this contract whether by road or rail are to be packed in containers which will be reasonably acceptable for further distribution.
- 7.2. The following minimum information shall appear on each package in English:
  - a) the description and quantity of the contents;
  - b) the expiry date; where only numerals are used the year shall be given in four digits;
  - c) the batch identification;
  - d) the word sterile and the sterilization method, where applicable;
  - e) the trade name or trademark of the manufacturer; and
  - f) Product code as relevant.
- 7.3. All containers, packages and cartons must be clearly labelled.

## **8. QUALITY ADHERENCE**

- 8.1. In the event that medical devices supplied during the contract period are reported by the end-user(s) to be defective, samples from the batch supplied to the end-user(s) shall be submitted by the department to accredited or recognized testing agency for testing.

- 8.2. The defected sample shall be compared to the reference sample originally submitted for evaluation.
- 8.3. Should the defective sample not differ significantly from the reference sample, the department shall be responsible for the cost of testing and vice versa.
- 8.4. A grace period of 30 days will be granted to the contractor to rectify product quality problems confirmed through testing. Failure to comply after the grace period, may lead the Department to invoke the provisions of the General Conditions of Contract. This may also lead to the termination of the contract and blacklisting of the company for poor contract performance.

## 9. SHELF LIFE

- 9.1. Upon delivery, all products must have at least 18 months of shelf-life before date of expiry. The service provider is allowed to make a prior arrangement in writing to supply products with shelf life of less than 18 months, in such cases the service provider shall uplift, at their own expense and reimburse the Department for the remaining unused products with no conditions attached once the 18 months lapses for the supplied stock.

## 11. KEY ASPECT OF THE BID PROPOSAL

Bidders must take note of the following fundamental aspects before submission of their bid proposals:

- 11.1. The bidder is expected to examine all instructions, forms, terms of reference and specifications in this bid.
- 11.2. In this bid document, words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter
- 11.3. Bidders must submit their bids on the stipulated closing date and time. Late bids shall not be considered.

- 11.4. In order to evaluate and adjudicate bids effectively, it is imperative that bidders submit responsive bids. To ensure a responsive bid it is imperative to comply with all conditions pertaining to the terms of reference.
- 11.5. Each bidder must attach all applicable documents in support of its bid in accordance with the requirements set out in this bid as well as any other relevant materials, photographs and/or attachments.
- 11.6. The department reserves the right to verify any information supplied by the bidder and should the information be found to be false or incorrect, the department will exercise any of the remedies available to it.
- 11.7. Each bid, once submitted, constitutes a binding and irrevocable offer to provide the services on the terms set out in the bid, which offer cannot be amended after its date of submission.
- 11.8. The department reserves the right to invite any bidder for a formal presentation during the evaluation process.
- 11.9. The department may, for any reason and at any time during the selection process, request any bidder to supply further information and/or documentation.

## **12. ADMINISTRATIVE REQUIREMENTS**

- 12.1.1. The LDoH has prescribed minimum administrative requirements that must be met by the bidders, in order for the former to accept the bid for evaluation. In this regard administrative compliance will be carried out to determine whether the bidder's bid comply in this regard.
- 12.1.2. Where the bidder fails to comply fully with any of the administrative bidding requirements below/under this bid or the LDoH is for any reason unable to verify whether administrative bidding requirements are fully complied with, the LDoH reserves the right, either to:
  - a. Reject the bid in question and not evaluate it at all.
  - b. Give the bidder an opportunity to submit and/or supplement the information and/or documentation provided so as to achieve full compliance with the administrative bidding requirements, provided that such information/documentation can be provided within the period that will be determined by the LDoH and such supplementary information/ documentation is only administrative and not substantive in nature. **The evaluation team shall agree on the maximum timeframe to be granted to furnish the information required.**
  - c. Permit the bid to be evaluated, subject to the outstanding information and/or documentation being submitted prior to the award of the bid.

- 12.1.3. **The LDoH may waive any minor informality or non-conformity or irregularity in a bid which does not constitute a material deviation, provided such waiver does not prejudice any bidder.**

### **13. BID AWARD AND CONTRACT CONDITIONS**

- 13.1. The shortlisted bidders shall be subjected to supply chain management screening process and only successful bidders who are cleared during screening shall be considered for appointment.
- 13.2. The department is not obliged to accept or consider any bid in full or in part or any responses or submissions in relation thereto and may reject any bid.
- 13.3. The award of the tender may be subjected to price negotiation with the preferred bidders.
- 13.4. **The department reserves the right to award the bid to one or more service providers wholly or in part or not to award.**
- 13.5. **The department reserves the right to negotiate price proposals submitted, prior to award**
- 13.6. The department further reserves the right to reject all or individual items of this bid and/or award all or individual items of this bid.
- 13.7. The department may, on reasonable and justifiable grounds, award the bid to a company that did not score the highest number of points.
- 13.8. The appointment of the successful bidder shall be subject to the conclusion of a Service Level Agreement (SLA) between the department and the successful bidder governing all rights and obligations related to the required services.
- 13.9. The contract shall be concluded between Limpopo Department of Health and the successful service provider(s).
- 13.10. The contract period will be in terms of the acceptance letter and it will commence on a date specified by the department in the letter of award of the contract and / or Service Level Agreement (SLA)
- 13.11. Bidders shall be notified about the decision of the Department by means of publication in the Provincial Bid Bulletin.
- 13.12. The outcome of the successful bidders shall be published through the same media that was used to advertise the bid.
- 13.13. Awarding of the bid shall be subject to the Service Provider(s) acceptance of National Treasury General Conditions of Contract (GCC).

#### **14. CONTRACT ADMINISTRATION**

- 14.1. The successful bidder must report to supply chain management contract unit immediately when unforeseeable circumstances will adversely affect the execution of the contract.
- 14.2. Full particulars of such circumstances as well as the period of delay must be furnished.
- 14.3. The administration of the bid and contract i.e. evaluation, award, distribution of contract circulars, contract price adjustments etc., shall be the sole responsibility of the Supply Chain Management Unit.

#### **15. RISK MANAGEMENT ON PRICING AND AWARDING**
