## THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME

### INTRODUCTION

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

### 1. PILLARS OF THE PROGRAMME

- 1.1 The NIP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US\$ 10 million or other currency equivalent to US\$ 10 million will have an NIP obligation. This threshold of US\$ 10 million can be reached as follows:
  - (a) Any single contract with imported content exceeding US \$10 million; or
  - (b) Multiple contracts for the same goods, works or services each with imported content exceeding US \$3 million awarded to one seller over a 2 year period which in total exceeds US \$10 million; or
  - (c) A contract with a renewable option clause, where should the option be exercised the total value of the imported content will exceed US \$10 million.
  - (d) Multiple suppliers of the same goods, works or services under the same contract, where the value of the imported content of each allocation is equal to or exceeds US\$ 3 million worth of goods, works or services to the same government institution, which in total over a two (2) year period exceeds US\$10 million.
- 1.2 The NIP obligation applicable to suppliers in respect of sub-paragraphs 1.1 (a) to 1.1 (c) above will amount to 30 % of the imported content whilst suppliers in respect of paragraph 1.1 (d) shall incur 30% of the total NIP obligation on a *pro-rata* basis.
- 1.3 To satisfy the NIP obligation, the DTI would negotiate and conclude agreements such as investments, joint ventures, sub-contracting, licensee production, export promotion, sourcing arrangements and research and development (R&D) with partners or suppliers.
- 1.4 A period of seven years has been identified as the time frame within which to discharge the obligation.

## **2 REQUIREMENTS OF THE DEPARTMENT OF TRADE AND INDUSTRY**

- 2.1 In order to ensure effective implementation of the programme, successful bidders (contractors) are required to, immediately after the award of a contract that is in excess of **R10 million** (ten million Rands), submit details of such a contract to the DTI for reporting purposes.
- 2.2 The purpose for reporting details of contracts in excess of the amount of R10 million (ten million Rands) is to cater for multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as provided for in paragraphs 1.1.(b) to 1.1. (d) above.

## **3 BID SUBMISSION AND CONTRACT REPORTING REQUIREMENTS OF BIDDERS AND SUCCESSFUL BIDDERS (CONTRACTORS)**

- 3.1 Bidders are required to sign and submit this Standard Bidding Document (SBD 5) together with the bid on the closing date and time.
- 3.2 In order to accommodate multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as indicated in sub-paragraphs 1.1 (b) to 1.1 (d) above and to enable the DTI in determining the NIP obligation, successful bidders (contractors) are required, immediately after being officially notified about any successful bid with a value in excess of R10 million (ten million Rands), to contact and furnish the DTI with the following information:
- Bid / contract number.
  - Description of the goods, works or services.
  - Date on which the contract was accepted.
  - Name, address and contact details of the government institution.
  - Value of the contract.
  - Imported content of the contract, if possible.

## **4. PROCESS TO SATISFY THE NIP OBLIGATION**

- 4.1 Once the successful bidder (contractor) has made contact with and furnished the DTI with the information required, the following steps will be followed:
- a. the contractor and the DTI will determine the NIP obligation;
  - b. the contractor and the DTI will sign the NIP obligation agreement;
  - c. the contractor will submit a performance guarantee to the DTI;
  - d. the contractor will submit a business concept for consideration and approval by the DTI;
  - e. upon approval of the business concept by the DTI, the contractor will submit detailed business plans outlining the business concepts;
  - f. the contractor will implement the business plans; and
  - g. the contractor will submit bi-annual progress reports on approved plans to the DTI.

4.2 The NIP obligation agreement is between the DTI and the successful bidder (contractor) and, therefore, does not involve the purchasing institution.

## 2 DEFINITIONS

- (a) “**B-BBEE**” means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;
- (b) “**B-BBEE status level of contributor**” means the B-BBEE status of an entity in terms of a code of good practice on black economic empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- (c) “**bid**” means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of goods or services, through price quotations, advertised competitive bidding processes or proposals;
- (d) “**Broad-Based Black Economic Empowerment Act**” means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (e) “**EME**” means an Exempted Micro Enterprise in terms of a code of good practice on black economic empowerment issued in terms of section 9 (1) of the Broad-Based Black Economic Empowerment Act;
- (f) “**functionality**” means the ability of a tenderer to provide goods or services in accordance with specifications as set out in the tender documents.
- (g) “**prices**” includes all applicable taxes less all unconditional discounts;

## 1. DEFINITIONS

Unless the context indicates otherwise, the following terms used in this bid shall have the following meaning:

<b>Bidder Agent</b>	Any person mandated by a prime Bidder or consortium/joint venture to do business for and on behalf of, or to represent in a business transaction, the prime Bidder and thereby acquire rights for the prime Bidder or consortium/joint venture against Department of Health or an organ of state and incur obligations binding the prime Bidder or consortium/joint venture in favour of the Department.
<b>Bidders</b>	Any enterprise, consortium or person, partnership, company, close corporation, firm or any other form of enterprise or person, legal or natural, which has been invited by the Department of Health to submit a bid in response to this bid invitation.
<b>Client</b>	Government departments, provincial and local administrations that participate in Department of Health procurement processes.
<b>Comparative Price</b>	The price after deduction or addition of non-firm price factors, unconditional discounts, etc.
<b>Consortium</b>	Several entities joining forces as an umbrella entity to gain a strategic collaborative advantage by combining their expertise, capital, efforts, skills and knowledge for the purpose of executing this bid.
<b>Department</b>	The Limpopo Department of Health (LDoH)
<b>Disability</b>	Means, in respect of a person, a permanent impairment of a physical, intellectual, or sensory function, which results in restricted, or lack of, ability to perform an activity in the manner, or within the range, considered normal for a human being.
<b>Electronic Gate-Keeping (EGK)</b>	The process of defining the criteria to be met to allow a test to be requested. The aim of the eGK is to prevent or minimise irrational and wasteful use of laboratory services

## 3. PURPOSE

The purpose of this terms of reference is to invite suitable service providers to submit a proposal for the provision of a Laboratory Test Gate Keeping Service in the Limpopo Department of Health (LDoH) for a period of thirty six (36) months renewable for further period of twenty-four months depending on the need.

## 4. INTRODUCTION

- 4.1 Despite the implementation of Electronic Gate Keeping (eGK) rules through the National Health Laboratory Service (NHLS) System, Limpopo Department of Health has not realised maximum benefits through this intervention.

- 4.2 There are still unnecessary costs incurred which can be managed by controlling the irrational ordering and repetition of orders compounded by the inaccurate billing of tests through the existing Laboratory Test Order System.

## **5. BACKGROUND**

- 5.1 The LDoH through its various health establishments send various tests to National Health Laboratory Service Laboratories.
- 5.2 The test results are delivered back to the healthcare facilities as hard copies / accessed through the SMS printers placed at each Primary Health Facility (PHC) / accessed from NHLS web-viewer (web based application managed centrally from NHLS / accessed via internet or a dedicated link).
- 5.3 The eGK rules for the control of laboratory test ordering were first implemented in 2017 on the NHLS Laboratory Information Management System (LIMS) commonly known as the Laboratory Information System (LIS), and are controlled at NHLS.
- 5.4 The eGK implementation through NHLS has not addressed some of the issues which are inherent to the LDoH, hence it became necessary for the LDOH to explore options whereby it introduces an eGK process before the NHLS or any Laboratory Service Provider eGK. This means that, tests will be subjected to a robust quality assurance process prior to being submitted to NHLS or any Laboratory Service Provider for processing.
- 5.5 NHLS remains a major cost driver in LDoH and inefficiencies have been identified which when addressed, would see an improvement in expenditure on laboratory services.

## **6. SCOPE OF WORK**

- 6.1 The scope of work includes the provision of a Laboratory Test Gate Keeping Mechanism in the Limpopo Department of Health for a period of thirty six (36) months. This may be renewable for twenty four (24) months at a time, based on the need.
- 6.2 The eGK rule-based mechanism will be employed in all requested test(s) whereby tests will either be approved or rejected before specimens are collected from the patient and / or sent to NHLS or any other Laboratory Service Provider. Transcription will be eliminated as the mechanism should be such that requests are processed electronically and quality assurance using the eGK rules currently implemented on the NHLS LIMS and other rules that may be implemented from the LDoH side, and any other rules that may be deemed to add value and enhance efficiency e.g. requestor's name and patient's hospital number. The proposed mechanism must be able to cater for

emergencies and where patient identification is proven difficult (e.g. in trauma cases and where it may be applicable).

6.3 In terms of item 6.2 above the attached technical specification (annexure B) details the requirements for electronic requests.

#### 6.4 **SKILLS TRANSFER AND CLIENT STAFF SKILLS UPLIFTMENT**

6.4.1 There must be a clear plan for skills transfer to LDoH. The bidder must provide training for healthcare facility end-user staff.

6.4.2 A training programme shall be included in the bid. In addition, a train-a-trainer / super-user approach shall also be considered and proposed.

6.4.3 The bidder must transfer technical skills and know-how to LDoH staff to enable them to render an effective and efficient support service to addressing complaints lodged by healthcare facilities.

6.5 The mechanism will be rolled out over a twelve month period. The proposed phases are as follows:

#### 6.6 **INTELLECTUAL PROPERTY RIGHTS**

6.6.1 The intellectual property of the system remains that of the service provider however, for this purpose all works created in terms of this bid and its assignments shall be deemed to have been created under the direction and control of the LDoH and

agreement must be entered into that secures the data of the state which remains an intellectual property of the state.

6.6.2 All data, data structures, forms and report formats newly designed or newly generated from scratch in the scope of work for the provision eGK services shall become the sole and exclusive property of the LDoH immediately upon acceptance of the service or service component.

6.6.3 Should a need arise for the amendment of clause 6.4.2 above, such shall be through a mutual agreement between the service provider and the accounting officer of LDoH.

## **8. KEY ASPECTS OF THE BID PROPOSAL**

Bidders must take note of the following fundamental aspects before submission of their bid proposals:

- 8.1 The bidder is expected to examine all instructions, forms, terms of reference and specifications in this bid.
- 8.2 **In this bid document, words in the singular also mean in the plural and vise versa and words in the masculine also mean in the feminine and neuter**
- 8.3 Bidders must submit their bids on the stipulated closing date and time. Late bids shall not be considered.
- 8.4 The bid document must be completed with indelible ink and alterations/corrections must be signed ( **No tippex/eraser allowed**);
- 8.5 In order to evaluate and adjudicate bids effectively, it is imperative that bidders submit responsive bids. To ensure a responsive bid it is imperative to comply with all conditions pertaining to the terms of reference.
- 8.6 Each bidder must attach all applicable documents in support of its bid in accordance with the requirements set out in this bid as well as any other relevant materials, photographs and/or attachments.
- 8.7 The department reserves the right to verify any information supplied by the bidder and should the information be found to be false or incorrect, the department will exercise any of the remedies available to it.
- 8.8 Each bid, once submitted, constitutes a binding and irrevocable offer to provide the services on the terms set out in the bid, which offer cannot be amended after its date of submission.
- 8.9 The department reserves the right to invite any bidder for a formal presentation during the evaluation process .i.e. After the bid closing date, the LDoH may call for presentations and demonstrations of the cloud computing software as a service centralised healthcare information system solution proposals. A bidder should be prepared to do so at a venue that is convenient to the LDoH depicting a live environment. All costs involved in the presentation or demonstration shall be borne by the bidder.
- 8.10 The department may, for any reason and at any time during the selection process, request any bidder to supply further information and/or documentation.

## **9. CONDITIONS ON ADMINISTRATIVE REQUIREMENTS**

- 9.1 The LDoH has prescribed minimum administrative requirements that must be met by the bidders, in order for the former to accept the bid for evaluation. In this regard administrative compliance will be carried out to determine whether the bidder's bid comply in this regard.
- 9.2 Where the bidder fails to comply fully with any of the administrative bidding requirements under this bid or the LDoH is for any reason unable to verify whether

administrative bidding requirements are fully complied with, the LDoH reserves the right, either to:

- a. Reject the bid in question and not evaluate it at all.
- b. 9.2.1 **The LDoH may waive any minor informality or non-conformity or irregularity in a bid which does not constitute a material deviation, provided such waiver does not prejudice any bidder.**

## **10. BID AWARD AND CONTRACT CONDITIONS**

- 10.1 The shortlisted bidders shall be subjected to supply chain management screening process and only successful bidders who are cleared during screening shall be considered for appointment.
- 10.2 The department is not obliged to accept or consider any bid in full or in part or any responses or submissions in relation thereto and may reject any bid.
- 10.3 The Department reserves the right to cancel and/or terminate the tender process at any stage, including after the Closing Date and/or after presentations have been made, and/or after tenders have been evaluated and/or after the preferred bidder(s) have been notified of their status as such.
- 10.4 The department reserves the right to negotiate pricing proposals with one or more preferred bidder(s) identified in the evaluation process, regarding any terms and conditions, including price without offering the same opportunity to any other bidder(s) who has not been awarded the status of the preferred bidder(s).
- 10.5 **The department reserves the right to award the bid to one or more service providers, wholly or in part or not to award.**
- 10.6 **The department may, on reasonable and justifiable grounds, award the bid to a company that did not score the highest number of points.**
- 10.7 The appointment of the successful bidder shall be subject to the conclusion of a Service Level Agreement (SLA) between the department and the successful bidder governing all rights and obligations related to the required services.
- 10.8 The contract shall be concluded between Limpopo Department of Health and the successful service provider(s).

- 10.9 The contract period will be in terms of the acceptance letter.
- 10.10 Bidders shall be notified about the decision of the Department by means of publication in the Provincial Bid Bulletin.
- 10.11 The outcome of the successful bidders shall be published through the same media that was used to advertise the bid.
- 10.12 **Awarding of the bid shall be subject to the Service Provider(s) acceptance of National Treasury General Conditions of Contract (GCC).**

## **11. CONTRACT ADMINISTRATION**

- 11.1 The successful bidder must report to supply chain management contract unit immediately when unforeseeable circumstances will adversely affect the execution of the contract.
- 11.2 Full particulars of such circumstances as well as the period of delay must be furnished.
- 11.3 The administration of the bid and contract i.e. evaluation, award, distribution of contract circulars, contract price adjustments etc., shall be the sole responsibility of the Supply Chain Management Unit.

## **12. RISK MANAGEMENT ON PRICING AND AWARDING**

- 12.1 All prices quoted by suppliers shall be assessed to ensure that bidders did not underquote. **(Bidders perceived to have underquoted in terms of market prices may be disqualified).**
