#### REQUEST TO WITHDRAW THE FOLLOWING BIDS:

HEDP004/20/21-SUPPLY, DELIVERY, INSTALLATION, COMMISSIONING AND MAINTENANCE OF GAMMA CAMERA , HEDP008/21/22-SUPPLY, DELIVERY, INSTALLATION, ACCEPTANCE, COMMISSIONING AND MAINTENANCE OF MAGNETIC RESONANCE IMAGING (MRI) UNIT (1.5T) TESLA AND HEDP017/21/22- SUPPLY AND DELIVERY OF PUBLIC HEALTH FACILITIES LINEN, PATIENT CLOTHING AND PROTECTIVE CLOTHING FOR DOCTORS, NURSES, FOOD SERVICE PERSONNEL AND GENERAL WORKERS IN LIMPOPO PROVINCE FOR THE PERIOD OF SIXTY (60) MONTHS, AS AND WHEN NEED ARISES.

## 1. PURPOSE

- 1.1. The purpose of this submission is to request the Chief Director: SCM to approve the withdrawal of the following bids:
  - 1.1.1 Hedp004/20/21-supply, delivery, installation, commissioning and maintenance of gamma camera,
  - 1.1.2 Hedp008/21/22-supply, delivery, installation, acceptance, commissioning and maintenance of magnetic resonance imaging (MRI) unit (1.5t) tesla.
  - 1.1.3 Hedp017/21/22- supply and delivery of public health facilities linen, patient clothing and protective clothing for doctors, nurses, food service personnel and general workers in Limpopo province for the period of sixty (60) months, as and when need arises.

### 2. PROCUREMENT DELAGATION

2.1. The Chief Director: Supply Chain Management is duly delegated to approve this transaction as guided by clause 3.17 of the latest revised Supply Chain Management Procurement Delegations that were approved by the Head of Department on 29/03/2022.

## 3. INTRODUCTION

- 3.1. The above-mentioned bid was previously advertised on 19 February 2021 in Tender Bulletin no.29 of 2020/21 FY and closed on 23 March 2021, with a hundred and twenty (120) days validity period.
- 3.2. The Head of Department approved the cancellation and re-advert for this bid on 03 March 2022 after the national treasury issued the instruction note to put on hold bids affected by the court ruling on the validity of the preferential procurement regulation 2017.

#### 4. DISCUSSIONS AND MOTIVATIONS

- 4.1. On the 25 March 2022, the department requested Provincial Treasury to cancel and re- advertise the above mentioned bid, The Provincial Treasury on the 04<sup>th</sup> April 2022 advised the Department to develop the evaluation method that will be used during the exemption period which should be captured in the Department's SCM Policy.
- 4.2. Supply Chain Management developed evaluation method and revised PPPFA Policy which was approved by the Head of Department on the 09 May 2022.
- 4.3. On the 27 May 2022 the Department advertised this bid on Tender bulletin no.08 of 22/23 FY dated 27 May 2022.
- 4.4. On the 30 May 2022 National Treasury issued a media statement that the Constitutional court has confirmed the suspension of the declaration of the order of invalidity of the 2017 Regulations is still valid for the remainder of the 12-month period, namely until 15 February 2023. This means that
  - a quotation requested or a tenders advertised before today must be dealt with in terms of the exemption and the internal procurement policy in place for the duration of the exemption. An organ of state may however decide to withdraw such a request for a quotation or an advert for a tender and request a new quotation or advertise a new tender that will be subject to 2017 Regulations;
- 4.5. Based on 4.4. above it is therefore requested that the Chief Director Supply Chain Management consider the withdrawal of the above mentioned bids.
- 4.6. Demand management unit is planning to re-advertise this bid on the 10 June 2022.
